Such candidates will produce a proof of minimum stay of one year along with original and photocopy of Service Book/ Discharge Book/ Casually Service Certificate (sexed from PO-3/ DAV as applicable) in case of Officers/ Airmen/ NCs (E) and a Certificate duly signed by OIC Civil Admin and counter signed by CO/ C Adm O of the last served unit, in case of Civilians.

- 9.5. Dental. Should have healthy gums, good set of teeth and minimum 14 dental points
- 9.6. General Health. Cardidate should be fit for the Air Force, must conform to the medical standards and should be of normal anatomy without loss or deformity of any appendages. Hel She should be free from any active or latent; acute or chronic, medical or suggical disability or communicable disease, infection and skin aliments. Candidate shall be physically and mentally FIT to perform duty in any part of the world in any climate and terrain.
- 9.7. Gynaecological Examination (For female candidates). The examination covers external genitalia, hernia orifices and the perineum, any evidence of stress urinary incontinence or genital prolapse cutside introlus.
- 9.8. Gender. Any candidate if bound to have predominant characteristics of the opposite gender as evident on externs physical examination, will be rejected as Unfit. Any candidate having undergone gender reassignment surgery will be declared Unfit.

- 30. Soon after the declaration of the result of Phase-I (Online) Test, a cut off will be applied on the normalised marks scored by the candidates in the Phase-I test and state-wise SHORTLISTED candidates will be sent a new Admit Card on their registered e-mail IDs for Phase-II test at a designated ASC as per their domicile cetspory chosen at the time of registration (refer pars 8).
