With reference to the subject cited above, I am to state that on the basis of demand put fourth by the students of Self-financing Courses (UG & PG) except 4-Years Integrated B.Ed. (Science & Arts) and PPP Mode Courses exclusively for the re-admission of students during Current Academic Session-2020-21 on 13-01-2021 and Students Strike in the front gate of the college on 13-01-2021 (from 09:30 A.M. to 12:15 P.M.), an emergent General Body Meeting of the college was convened at 12:30 P.M. on 13-01-2021. The General Body of the college unanimously resolved to submit proposal for reduction in Course fees in respect of Self-Financing Courses (UG & PG) except 4-Years Integrated B.Ed. (Science & Arts) and PPP Mode Courses exclusively for the re-admission of students during Current Academic Session-2020-21 by 15% to the Principal Secretary to Government, Higher Education Department, Government of Odisha for necessary approval.

In this context, may I request your good office to undertake necessary steps for reduction in course fees in respect of Self-Financing Courses as mentioned above exclusively for the re-admitted students during the Current Academic Session 2020-21 for accordance of necessary approval.

## RESOLUTIONS OF GENERAL BODY MEETING HELD AT 12.30 PM ON 13-01-2021

A General Body Meeting of all categories of the staff of the College was held in the Conference Hall of the College at 12.30 PM on 13.01.2021 to discuss the memorandum submitted by students of SFCs regarding reduction of Course Fees for the purpose of readmission during the current Academic Session 2020-21. Principal, Dr. (Smt.) Jharana Behera presided over the meeting and appraised the house regarding the memorandum submitted by the students.

After threadbare discussion on the pros and cons of reduction of Course Fees to the extent of 40% both Teaching & Non-teaching staff members expressed their view points that the SFCs cannot be managed with 40% reduction in Course Fees.

The house unanimously resolved:

(a) To reduce the Course Fees by 15% in respect of UG & PG SFCs except Int. B.Ed. and PPP mode courses for the purpose of Re-admission of students for the current Academic Session 2020-21 subject to approval from the Principal Secretary to Govt., Higher Education Department Govt. of Odisha for which correspondence will be made with Higher Education Department Govt. of Odisha on priority basis. The reduced fees structure for the students to be re-admitted exclusively for the current Academic Session 2020-21 is mentioned below.

## Addendum to the Resolutions of Staff Council Meeting held in the Conference Hall of the College at 2.30 PM on 07.01.2021 vide Principal's Notice No. 58, Dt.07.01.2021

Justification / rationale behind reduction in Course Fees of 4-Year Int. B.Ed. (Science & Arts) by 40% exclusively for the students to be re-admitted for the current Academic Session 2021 in view of COVID-19 Pandemic crisis and financial constraints faced by the students.

- (a) The intake capacity of 4-Year Int. B. Ed. (Science & Arts) per annum is 400.
- (b) Int. B. Ed. (Science & Arts) students of 1<sup>st</sup> Year, 2<sup>nd</sup> year & 3<sup>rd</sup> Year being imparted teaching in respect of Core Papers by various Departments having Regular and Guest Faculties receiving their Salary / Remuneration from Higher Education Department, Govt. of Odisha.
- (c) Int. B. Ed. (Science & Arts) students being imparted teaching in respect of B. Ed. related Papers from 1<sup>st</sup> Year to 3<sup>rd</sup> Year and exclusively Methodology Papers in 4<sup>th</sup> Year by Guest Faculties engaged and paid out of Int. B.Ed. (SFC) Fund.
- (d) Since the Course Fees is Rs.35,000/- per student per Admission Batch, after 40% reduction of Course Fees the Re-admitted students will pay Course fees @ Rs.21,000/- exclusively for current Academic Session 2020-21.
- (e) The balance position of Int. B.Ed. is sound for which Coordinator of Int. B.Ed. expressed his consent for sound financial management for the current Academic Session with reduced Course Fees.
